Abortion-determined by Gayle Irwin

During the past 18 months, we have assessed more than half of True Care's patients as likely to abort. The ones that are "abortion-determined" are the hardest cases; many have already scheduled an abortion but want to know how far along they are to see if they qualify for the abortion pill.

More of the patients we assess as abortion-determined choose to abort than do those we asses as abortion-vulnerable or abortion-minded. We are thankful for the opportunity to share truth with them and to make an impact on those who

carefully consider what they see and learn at True Care.

Twenty-year-old "Leah" came into our Center. She told the Advocate that she and her boyfriend agreed that she should abort. Therefore, the Advocate assessed her as abortion-determined. Leah also had financial concerns since she worked a minimum-wage job, and fears about her health and safety due to a history of anemia.

After a positive pregnancy test, our Nurse estimated that Leah was about six weeks along. An ultrasound revealed her unborn child on the screen. Then Leah rejoined her Advocate in the consulting room to discuss all of her pregnancy options. They reviewed the abortion brochure, including the potential emotional side effects of abortion. The Advocate gave Leah an after-abortion brochure regarding self-care, a patient safety checklist and a pro-and-con sheet. She encouraged Leah to read them and seriously consider her options. Our young patient also learned about True Care's in-house programs: Baby & Me and the Resource Program.

Leah and her Advocate talked about a support system. Our patient believed her family would Leah left support carrying to term and that her boyfriend might come around to the True Care idea if that's what she chose to do. However, she said he believed abortion was their best option and that she agreed with him. Leah left True Care that that day day planning to abort. planning

to abort. Less than a month later, Leah called to let us know she had changed her mind regarding abortion, and she set up an appointment with our Resource Coordinator. The young woman not only enrolled in the Resource Program, but she also signed up and completed Baby & Me. She also participated in one of the local Embrace Grace programs at a church in town.

During the summer Leah gave birth to a beautiful baby girl!

Even though most abortion-determined women don't change their minds, True Care does make an impact on some of them. So much so that we often see a woman who has chosen abortion in the past return with a new pregnancy. We are able then to offer our Abortion Recovery Program and remind them of the many in-house and community resources available to help them continue the new pregnancy. We serve all women with love and compassion, and they feel comfortable returning to True Care.

Leah is a beautiful example of a life transformed, from abortion-determined to being a mother, from being far from God to becoming a child of the Most High King. Thanks to our Nurses, Advocates, Prayer Warriors, Church Partners, Donors and Supporters, together we save lives – the unborn child and the mother.

# From the CEO



#### What Happens if Roe is Overturned?

The Supreme Court of the United States has agreed to hear a Mississippi case, Dobbs v Jackson Women's Health. The Mississippi case involves the state's legislation prohibiting abortions after 15 weeks gestation and directly challenges Roe v Wade, the case that made abortion legal in the US in 1973. The Supreme Court is scheduled to hear oral arguments in this case on December 1. The court is expected to uphold the Mississippi law and could possibly overturn Roe. However, we most likely won't know the high court's decision until the second quarter of 2022.

For the past 50 years, life-affirming people across our great country have been working tirelessly to do whatever they can to end abortion. Their efforts have resulted in many states passing restrictions on abortion such as mandatory waiting periods, parental consent laws, and informed consent legislation that requires women to have an ultrasound before undergoing an abortion procedure.

While we wait to see how the high court will rule, we wonder what effect a reversal of the so-called "constitutional right to abortion" will have for those of us who have been involved in the battle for the sanctity of all human life. Will pro-life organizations dismantle and shut down because the battle will be won? Will pregnancy centers close their doors because they will no longer be needed?

The answer is a definite no. In fact, the need for pro-life organizations will be greater than ever as the legality of abortion will be determined by each individual state. Many states, such as California and New York, have already passed legislation guaranteeing that abortion will remain legal in their states should the federal law be overturned.

As a recent article written by Heartbeat International states: "The end of the "right to abortion" will not be an end to abortion in our land. Even if it were outright outlawed (which is nowhere near a possibility in our foreseeable political climate), there would still be predatory abortion services. Every woman will still need to be loved and supported in her pregnancy—especially unintended ones."

We anxiously await the Supreme Court's decision on the legality of a law that has been a scourge on our land for so many years, and we will celebrate this tremendous victory if it comes. But we also realize that our work will not be over. Pregnancy centers like True Care and other life-affirming organizations aren't going anywhere. We will continue to stand our ground in the battle for life! That is why we press forward in our mission to offer hope to each person who calls or walks through our doors. No matter what happens in Washington, there will still be a need for the life-affirming care we provide.

We may not know what the outcome of this Supreme Court case will be, but we do know this: We have a job to do. And each day, we're one step closer to fulfilling the mission God has for us.

The majority of women who come to us are single. People may assume if a woman is married she isn't at risk of choosing abortion. However, being married doesn't automatically mean the pregnancy is planned or wanted.

One such case is Ann, a 20-year-old married Asian woman, who contacted True Care for an appointment. Ann's husband is stressed because his visa just ran out and he is worried about being deported. He is applying for US citizenship. He also recently had emergency surgery to remove his appendix and is temporarily unable to work. Ann's husband is paid in cash at his job and she does not work. Finances are a big concern for this couple.

Ann and her husband have always used Plan B, the morning after pill, as contraception, but it did

It isn't even a baby yet and we can't afford it not work this time and they have no medical insurance. Ann says they had planned to wait for ten years before having any children.

When Ann came to True Care for her first appointment, her husband was not with her. She shared that he really wanted her to abort because "it isn't even a baby yet and we can't afford

it." The nurse offered Ann a second ultrasound since she was undecided about the outcome of her pregnancy, but she declined. The nurse scheduled Ann for an appointment with me by phone for the following week.

When I connected with Ann we discussed all of the resources that would help them. I completed a full Medicaid application and a temporary Medicaid application (PE), which was complicated by her husband's immigration status and his "under the table" salary. However, I have made very good contacts at the Wyoming Medicaid Department over the last eight years and I was able to get answers to this complicated situation. I also scheduled Ann for True Care's Baby and Me classes.

Ann arrived at True Care the next week to receive her Medicaid letter and other resources. To our surprise, her husband was with her. The three of us met and discussed their situation. I encouraged them to have a second ultrasound following our time together to let her husband meet his baby!

In the ultrasound room, the nurse pointed out the ten-week-old unborn child. Ann's husband saw a tiny heart beating at 170 beats per minute. He witnessed his baby moving around. The nurse shared with him all the things that were happening with his baby developmentally, such as fingers and toes and organs being formed. Immediately following the ultrasound, Ann's husband said he had changed his mind. Now that he saw his baby and he realized the help the Resource Program can provide, he would no longer put pressure on his wife to abort. Together, they would prepare to become parents!

We have learned never to assume anything! We must take the time to listen, to learn more about each situation, and to offer resources-- no matter what a couple's marital status is. It is a privilege to serve the women in our community facing unplanned pregnancies!

The Resource Program is open to all True Care patients and officially began in January 2013. During this time Cheryl has enrolled 963 patients in the program and made more than 6741 patient contacts. She has completed 1,012 Medicaid applications. So far, 718 babies have been born to women who enrolled in the program.
